B CIRCUIT RULING #29

MEETING: Evergreen Park, Grande Prairie, Alberta, Canada

July 27, 2024

On Monday, July 22, 2024, the Canadian Pari-Mutuel Agency Reference & Research Laboratory, Ottawa, Ontario, in accordance with Section 165 of the Pari-Mutuel Betting Supervision Regulations, have reported that the urine sample of the horse "LANDRY KYLE", first place finisher in Race 5, Sunday, July 14, 2024, tested POSITIVE for the drug COBALT.

In accordance with HORSE RACING ALBERTA Licensing Rules 66, 67, 68 and 139(1)(2), OWNER/TRAINER, AUTHORIZED AGENT, CHANDRA OPAL LUCETTE CLARK, PERM. ADD.: GRANDE PRAIRIE, ALBERTA, CANADA, D.O.B. DECEMBER 15, 1975, is hereby SUSPENDED AND DENIED THE PRIVILEGES OF THE GROUNDS (INCLUDING GRANDSTAND) OF ALL ALBERTA RACETRACKS FOR A PERIOD OF THIRTY (30) CALENDAR DAYS AND FINED THE SUM OF ONE THOUSAND DOLLARS (\$1,000.00). Chandra Clark's suspension shall commence on Saturday, July 27, 2024, through to Sunday, August 25, 2024 (inclusive).

Effective Saturday, July 27, 2024, all horses owned or trained by Chandra Clark shall be denied entry pending their sale or transfer satisfactory to the Board of Stewards.


The horse "LANDRY KYLE" is hereby DISQUALIFIED and declared UNPLACED with the purse money redistributed by the Horsemen's Bookkeeper as follows: 1st: "EDGE OF OKOTOKS"; 2nd: "SAYITALL"; 3rd: "WORKIN NINETOFIVE"; 4th: "SIZZLE N SUSIE". All monies earned by "LANDRY KYLE" must be returned to the Horsemen's Bookkeeper. In accordance with Rule 292(1) "LANDRY KYLE" is ineligible to race for a period up to fifteen (15) calendar days and will be placed on the Steward's List. The horse may be considered for a reduced penalty after seven (7) days, if the Owner/Trainer provides a negative test result at their own expense and under the supervision of the Official Veterinarian.


In accordance with HORSE RACING ALBERTA Rules 261, 264, 265, 266, 279, 286, 287(1)(xx), and 296(1)(a)(2)(a)(b)(f)(g).

Fine to be paid before reinstatement.

This ruling shall in no way affect the Pari-Mutuel wagering.
